2. Consent form signed by the owners and occupants of all dwelling units within a multi-family dwelling unit consenting to the classification of the multi-family dwelling unit, including all dwelling units located therein, being classified as commercial.

OR

Application for exemption from mandatory collection requirements for self-hauling municipal solid waste and recyclable materials to the Highlands County Solid Waste Management Center (HCSWMC) located at 12700 Arbuckle Creek Rd., Sebring, FL 33870 or for composting municipal solid waste on-site and self-hauling recyclable materials to the HCSWMC. No containers are provided by Highlands County or Progressive Waste Solutions of FL, Inc., a Delaware corporation, d/b/a Waste Connections of Florida for collection of solid waste or recyclable materials for self-hauling.

I understand that if I do not continue to comply with the requirements for commercial classification Highlands County will revoke my commercial classification and my property will be assessed a non-ad valorem assessment for solid waste and recycling services.
