GENERAL DESCRIPTION:

A skilled position responsible for tire repair of automotive, construction and other various types of public works equipment.

ESSENTIAL JOB FUNCTIONS:

The following statements describe the principal functions of the job and its scope of responsibility but should not be considered an all-inclusive list of work requirements. Individuals may perform other duties as assigned.

- Provides tire replacement recommendations regarding pricing and availability.
- A skilled position with knowledge of all aspects of light, medium and heavy duty tire repair.
- Operates a Field Equipment Service Truck. Uses tire repair equipment. Uses knowledge of tire sizes and applications on vehicles and equipment.
- Provides general assistance to helpers in the garage with troubleshooting and in making general repairs.
- Performs general clean-up duties in the shop.
- Occasionally operates transport semi to move equipment.
- Responds productively to change and performs all other related tasks as required and as directed.

KNOWLEDGE, SKILLS & ABILITIES:

- Knowledge of the methods, materials, tools and standard practices of the automotive mechanic trades.
- Knowledge of the occupation hazards and safety precautions of the trade.
- Knowledge of the operating and repair characteristics of a wide variety of public works equipment tires.
- Knowledge of industrial tire repair equipment, methods, and techniques.
- Skill in the use of tools, machines and testing instruments of the trade.
- Ability to understand and communicate oral and written instructions.

PHYSICAL SKILLS:

The individual in this position must be able to remain in a stationary position for 10% of the time. Frequently operates various types of equipment to include, but not limited to hand and power tools. Frequently ascends/descends stairs, ladders and scaffolding. The person in this position frequently communicates with the public, vendors and co-workers. Must be able to exchange accurate information in these situations. Frequently moves materials and office equipment weighing up to 50 lbs. Frequently works in outdoor weather conditions. May be required to work in inclement outdoor weather conditions for up to four (4) hours. Frequently operates motor vehicle for up to eight (8) hours; of which four (4) may be continuous. Must be able to frequently position self to work under or around various items to perform maintenance tasks. Constantly inspects and assesses equipment, buildings and materials to complete daily tasks. Frequent exposure to moderately high noise levels. Frequently works indoor in an automotive repair shop.

MINIMUM QUALIFICATIONS:

Graduation from an accredited high school or possession of an acceptable equivalency diploma preferred. Three (3) years Journeyman level experience in tire repair.

LICENSE, CERTIFICATIONS, or REGISTRATIONS:

Must possess and maintain a valid Florida Driver's License, Class B by end of six (6) month probation.
